Who can work from DMCC Free Zone?

What you need to know

- It is illegal for any employer to retain the services of an individual that does not have approval to perform duties in the DMCC Free Zone.
- Authorisation to perform employment duties in DMCC Free Zone takes three main forms;
- 1. Employee Residence Permit (Visa)
- 2. Employee Identity Card
- 3. Access Approval
- Any employee on an Employee Residence Permit (Visa) or with a DMCC Employee Identity Card must hold a valid Employment Contract with the Free Zone company.


When does a visa amendment need to be stamped in the passport?

Which type of authorization is required?




^{*}Access Approvals are limited to no more than 30% of the workers performing services from a company's place of business.



What is a valid Services Contract?


Your company may, at times, have employees from another company working from your office, sometimes know as 'embedded contractors'. You must ensure that you have entered into a valid service contract with that company before allowing any of their employees to work from your office location.



^{*}Access Approvals are limited to no more than 30% of the workers performing services from a company's place of business.



What type of Service Request is needed for the Residence Permit?




^{*}This process enables the employee to remain in the UAE during the process, and if they are the sponsor of others those visas can also be transferred.

^{**}This process incurs an additional charge but enables the employee to remain in the UAE during the process



Next steps after the Entry permit is activated



*If the Entry Permit is not activated or expires and is not renewed the company MUST cancel it

^{**}Once the Entry Permit is activated the individual cannot exit the UAE until the Residence Permit (Visa) is stamped in the passport.

^{***}Only two renewals are allowed




Quick check - In/Out country

Will the employee exit UAE and return?	Yes Must exit if on tourist or transit visa.	Yes Must exit if on tourist or transit visa.	No	N/A
Instructions	Employee brings original EP with them and activates (handover at airport immigration) it at immigration on return to UAE.	Once issued the employer deposits EP at airport and emails copy to employee OR Sends original to employee for activation on arrival at immigration. Employee must show EP to airport immigration.	After EP is issued employer commences position amendment process. Employee can stay in the UAE.	Employer deposits EP at airport and emails copy to employee OR Sends original to employee for activation on arrival at immigration. Employee must show EP to airport immigration.



Change to employment terms during RP validity period




^{*}DMCC requires all companies to update salary details on the portal to ensure that up to date records are kept for all employees, ensuring proper calculation of benefits.

^{**}Under UAE immigration rules it is required to amend the employee residence permit if there is a change of job title.



What to do if a visa is expired or about to expire?



When an Employee Residence Visa expires the company is required to ensure the visa is either renewed, cancelled, or notified as an absconder if the employee cannot be located.

Under UAE immigration rules one of the above steps MUST be taken.
